## **Consumer Price Index for All Urban Consumers in Iran**

Aban 1393

(1390=100)

The Consumer Price Index (CPI) increased 1.5 percent in Aban 1393<sup>1</sup> following 1.4 percent rise in Mehr 1393. The index level of 207.8 was 15.1 percent higher than in Aban 1392.

For the first eight months of 1393, the consumer price index rose 15.2 percent, compared to the similar period in 1392.

The inflation rate has advanced 18.2 percent over the last twelve months.

The food and beverages index increased 1.2 percent in Aban, largely due to the increases in the indices for ground vegetables by 44.1 percent, root vegetables 9.0 percent, leafy green vegetables (except lettuce) 4.7 percent, rice 0.8 percent, milk products 1.0 percent, nuts 2.1 percent, sugar, sugar lump, jam, honey, chocolate and confectionary 1.4 percent, grape 9.3 percent, fish 1.6 percent, biscuit, cake and cookies 1.4 percent, livestock meat 0.2 percent, beverages 0.6 percent, apple 0.7 percent, pasta 1.7 percent, vegetable products 0.6 percent, lime 3.0 percent, date 2.4 percent, and salt, spices, sauces, condiments and food products 0.7 percent. Within the food and beverages group, decreases in the indices for poultry and citrus (except lime) each by 9.3 percent, banana 12.4 percent, egg 2.8 percent, lettuce 5.7 percent, pomegranate 4.9 percent, and kiwi fruit 2.3 percent were also considerable in this month.

The index for tobacco went down 1.1 percent in Aban, reflecting 1.3 percent decrease in the index for imported cigarettes.

The clothing and footwear index rose 1.5 percent, mostly as a result of the increase in the index for ready to wear clothing by 1.8 percent. Advances in the indices for footwear by 0.8 percent, clothing materials 0.7 percent, and tailoring, cleaning and laundering wage 1.6 percent, accounted for the rise of this group index as well.

During this month, the housing, water, electricity, gas and other fuels index increased 1.4 percent which was attributed to the advances of the indices for “rental

equivalence of owner occupied houses” and “rent of residential houses” each by 1.6 percent and maintenance and repair services of the dwelling 1.0 percent.

The furnishings, household equipment and routine household maintenance index rose 0.6 percent, mainly due to the rises in the indices for furniture and furnishings, carpets and other floor coverings by 1.6 percent, goods and services for routine household maintenance 0.8 percent, glassware, tableware and household utensils 0.2 percent, and household textiles 0.3 percent.

The index for health went up 2.1 percent, mostly as a result of the increases in the indices for hospital services by 4.5 percent, medical, paramedical and dental services 1.0 percent, and medical products, appliances and equipment 0.9 percent.

The transport index decreased 0.1 percent, largely due to the decrease in the index for personal transport vehicles by 1.0 percent. Within this group, increases in the indices for operation of personal transport equipment and passenger transport by road each by 0.5 percent, were also considerable in this month.

The index for communication turned down 1.2 percent in Aban, reflecting 8.7 percent decrease in the index for telephone equipment.

The recreation and culture index rose 11.6 percent that was principally attributed to the advances of the indices for school textbooks by 116.4 percent, other recreational items and equipment 1.1 percent, and recreational and cultural services 0.5 percent. Within this group, decreases in the indices for package holidays by 0.7 percent, and TV, radio, recording and reproduction of sound and pictures 0.3 percent were also considerable in this month.

The education index went up 1.3 percent over this month, mostly as a result of the increase in the index for private schools and supplementary courses tuition fees by 2.9 percent.

The index for restaurants and hotels rose 1.1 percent, mainly due to the advances in the indices for food away from home by 1.3 percent and catering services 0.8 percent.

The miscellaneous goods and services index increased 0.9 percent in this month. Increases in the indices for personal care by 0.7 percent, personal effects 1.4 percent, and nursery schools tuition fees 14.8 percent were the major reasons for this rise.

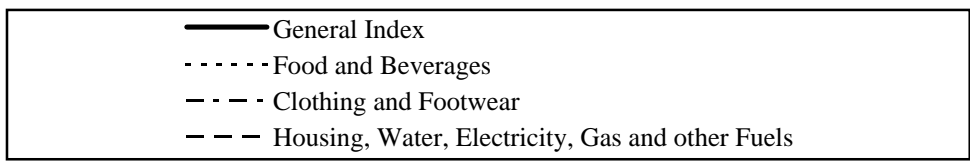
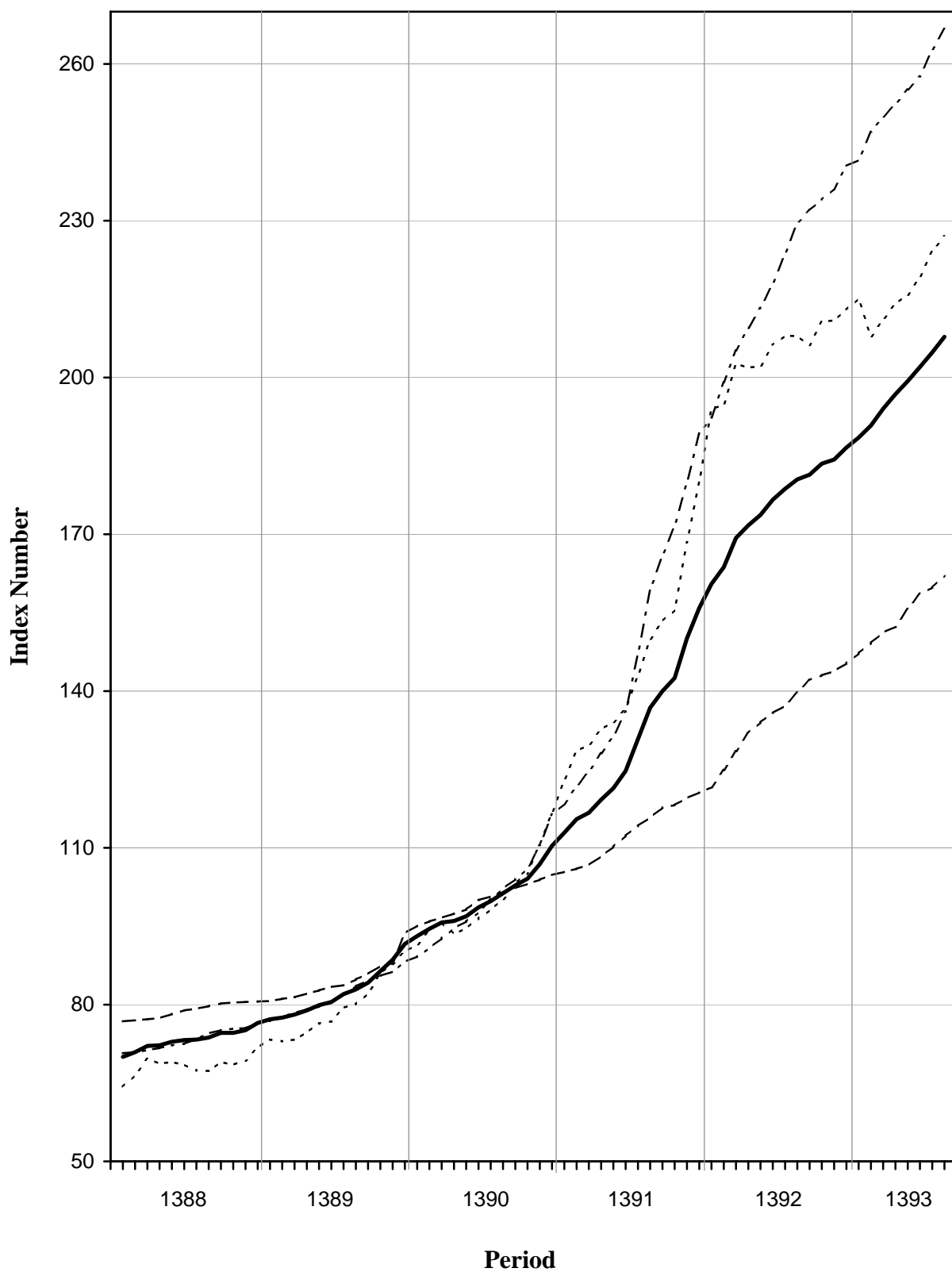
