Consumer Price Index for All Urban Consumers in Iran

Shahrivar 1395

(1390=100)

The Consumer Price Index (CPI) increased 0.7 percent in Shahrivar 1395¹. The index level of 247.1 was 9.5 percent higher than in Shahrivar 1394.

For the first six months of 1395, the consumer price index rose 8.1 percent compared to the similar period in 1394.

The inflation rate has advanced 8.8 percent over the last twelve months.

The food and beverages index turned down 0.2 percent in Shahrivar, largely due to the decreases in the indices for fresh fruits (except banana and melon) by 6.4 percent, poultry 2.9 percent, ground vegetables (except cucumber and zucchini) 5.2 percent, Iranian rice 0.9 percent, fish (from the Persian Gulf and the Oman sea) 3.0 percent, potato 4.4 percent, and pease 1.0 percent. Within the food and beverages group, increases in the indices for livestock meat by 1.5 percent, banana 9.8 percent, sugar, sugar lump, jam, honey, chocolate and confectionary 1.3 percent, cucumber 4.6 percent, fish (except fish from the Persian Gulf and the Oman sea) 4.3 percent, oils and fats 1.7 percent, dairy products and eggs 0.4 percent, beverages 1.1 percent, leafy green vegetables 2.0 percent, imported rice 0.9 percent, melon 5.9 percent, pulses (except pease) 1.6 percent, biscuit, cake and cookies 0.8 percent, nuts 0.4 percent, carrot 4.8 percent, zucchini 4.4 percent, meat products 1.4 percent, vegetable products 0.4 percent, canned fish 0.9 percent, pasta 0.5 percent, and salt, spices, sauces, condiments and food products 0.2 percent were also considerable in this month.

The index for tobacco was virtually unchanged in Shahrivar.

The clothing and footwear index increased 0.5 percent, mostly as a result of the increases in the indices for ready to wear clothing by 0.3 percent, foot wear 0.7 percent, tailoring, cleaning and laundering wage 1.4 percent, and clothing materials 0.6 percent.

During this month, the housing, water, electricity, gas and other fuels index went up 1.1 percent which was attributed to the advances of the indices for "rental

equivalence of owner occupied houses" and "rent of residential houses" each by 1.2 percent, and maintenance and repair services of the dwelling 0.7 percent.

The furnishings, household equipment and routine household maintenance index rose 0.5 percent, largely due to the increases in the indices for glassware, tableware and household utensils 1.0 percent, household appliances 0.6 percent, goods and services for routine household maintenance 0.4 percent, furniture and furnishings 0.2 percent, and household textiles 0.3 percent.

The index for health increased 1.7 percent, mostly as a result of the increases in the indices for hospital services by 2.6 percent, medical, paramedical and dental services 1.4 percent, and medical products, appliances and equipment 0.7 percent.

The transport index went up 0.9 percent in Shahrivar that was principally attributed to the increases in the indices for personal transport vehicles by 1.4 percent, passenger transport by road 1.0 percent, and operation of personal transport equipment 0.4 percent.


The index for communication rose 0.2 percent, mostly as a result of the increase in the index for telephone equipment by 1.7 percent.

The recreation and culture index increased 3.3 percent, largely due to the increases in the indices for books, newspapers and stationery by 6.6 percent, package holidays 4.5 percent, recreation and cultural services 1.2 percent, audio-visual, photographic and information processing equipment 0.4 percent, and other recreational items and equipment 0.6 percent.

The education index advanced 0.4 percent over this month, mostly as a result of the increase in the index for private schools and supplementary courses tuition fees by 0.8 percent.

The index for restaurants and hotels rose 0.5 percent, mainly due to the advances in the indices for "food away from home" and "catering services" each by 0.5 percent, and accommodation services 0.9 percent.

The miscellaneous goods and services index increased 0.7 percent in this month. Increases in the indices for personal care by 0.6 percent, and personal effects 2.1 percent, and goldsmith wage 0.7 percent were the major reasons for this rise.
