

#### **Producer Price Index in Iran**

Mehr 1397

#### (1395 = 100)

The Producer Price Index (PPI) went up 11.5 percent in Mehr 1397. The index level of 176.0 was 59.0 percent higher than in Mehr 1396.

For the first 7 months of 1397, the PPI edged up 30.1 percent, compared to the similar period in 1396.


This index moved up 22.4 percent for the 12 months ended in Mehr 1397.

**Agriculture, forestry and fishing:** In Mehr, a 10.6-percent increase in the prices of this group can be traced to the rises in the indices for millets, sesame, pulses, growing of rice, melons, potatoes, onions, garden vegetables, growing of cotton, corn, grapes, oranges, sweet lemons, growing of pome and stone fruits, fresh nuts, barberry, raising of cattle and buffaloes, poultry, and fishing and aquaculture. In contrast, price of olives went down.

**Manufacturing:** The Manufacturing group index moved up 14.3 percent, which was mostly due to the rises in the indices for production of meat products, dried nuts and fruits, manufacture of dairy products, starches, "manufacture of cocoa, chocolate and sugar confectionery", "tomato paste and sauces", manufacture of soft drinks, cigarettes, preparation and spinning of textile fibres, manufacture of carpets and rugs, manufacture of particle board

and high pressure laminate, manufacture of paper and paper products, pentane, manufacture of paraffin wax and vaseline, tar, methanol, paraxylene, phthalic anhydride, toluene, manufacture of basic chemicals (for export), fertilizers and nitrogen compounds (for domestic uses), manufacture of plastics and synthetic rubber in primary forms, oil-based paints, "manufacture of soap and detergents, cleaning and polishing preparations, perfumes and toilet preparations", industrial adhesives, respiratory medicines, musculoskeletal medicines, manufacture of plastic articles for the packing of goods, "sponge, integral and foam", manufacture of clay building materials, iron beam, iron sheets, production of ferro-alloys, "manufacture of basic precious and other non-ferrous metals", manufacture of structural metal products, flanges, metal cans, video door phones, manufacture of televisions, gas meter, gas regulators, manufacture of electrical equipment, "manufacture of other compressors, pumps and taps", manufacture of burners, elevators, industrial heaters, scales and weighbridges, tractors, manufacture of metal-forming machinery and machine tools, manufacture of buses, pickup trucks, trailers and semi-trailers, manufacture of parts and accessories for motor vehicles, and manufacture of medical and dental instruments and supplies. On the contrary, prices for poultry, plastic pipe and fittings, and manufacture of metal-rolling mills and rolls for such mills declined.

**Services:** Increases in the indices of freight by trucks, restaurants and tuition of private schools led to 7.2 percent rise in the services group index.
