Producer Price Index in Iran

Tir 1383

(1376 = 100)

The Producer Price Index (**PPI**) went up 0.8 percent in Tir 1383. Showing the index point of 279.4, the **PPI** was 14.9 percent higher than the similar month in 1382.

During the first four months of the current Iranian year, the Producer Price Index rose 16.5 percent compared to the similar period in 1382.

On the average, the Producer Price Index increased 15.9 percent during the last twelve months leading to Tir 1383 compared with the similar preceding period.

In Tir, the agriculture, animal husbandry and forestry group index rose 0.7 percent.

The fishing group index went down 7.4 percent, which was attributed to the reduce in the prices of Caspian Sea and Persian Gulf fish.

The mining and quarrying group index increased 3.2 percent.

The manufacturing group index declined 0.1 percent.

The advance in the price of water for household usage caused 2.0 percent rise in the group index of electricity, gas and water supply.

The repairing of motor vehicles group index and the hotels and restaurants group index rose 2.7 percent and 1.2 percent, respectively.

The 2.6 percent increase in the group index of transport, storage and communications was due to the rise in the prices of land transport.

The financial intermediation group index went up 4.6 percent, which was attributed to the increase in the prices of service charge of stock exchange.

The advance in the prices of construction services caused 1.4 percent rise in the group index of real estate, renting and business activities.

The education group index went up 0.1 percent.

The 1.8 percent increase in the group index of health and social work was due to the rise in the prices of medical activities.

The other community, social and personal service activities went up 0.5 percent.



