Export Price Index in Iran

Mordad 1386

(1376 = 100)

The Export Price Index (**XPI**) went down 0.1 percent in Mordad 1386. Showing the index point of 541.2, the **XPI** was 11.0 percent higher than the similar month in 1385.

During the first five months of the current Iranian year, the **XPI** increased 14.7 percent compared to the similar period in 1385.

The **XPI** rose 15.6 percent during the last twelve months leading to Mordad 1386 compared with the similar preceding period.

The 0.1 percent decline in the **XPI**, in Mordad 1386, was mainly due to some decreases of 1.4 percent in the propane price index, 3.3 percent in the benzene price index, 1.8 percent in the hot coil iron price index, 9.3 percent in the ammonia price index, 15.1 percent in the zinc-oxide price index, 4.1 percent in the zinc-concentrate price index, 1.7 percent in the butane price index, 0.8 percent in the copper price index, 1.5 percent in the sheep assorted casing price index and 1.1 percent in the jet fuel price index. In this month, the increase in the index prices of processed sheep skins, hand-woven carpet, pistachio, sulfur, saffron, syringe, tar, clothing, soap and cumin were considerable.

In Mordad 1386 compared to the similar month of the previous year, there were some increases of 15.1 percent in the vegetable products group index, 17.6 percent in the animal or vegetable fats and oils group index, 3.9 percent in the prepared foodstuffs, beverages and tobacco group index, 9.8 percent in the mineral products group index, 14.5 percent in the products of the chemical or allied industries group index, 0.8 percent in the plastics and articles thereof, rubber and articles thereof group index, 29.4 percent in the skins and leather and articles thereof group index, 92.1 percent in the wood and articles of wood group index, 12.6 percent in the textiles and textile articles group index, 8.8 percent in the articles of stone group index, 8.7 percent in the base metals and articles of base metal group index, 52.5 percent in the machinery and mechanical appliances, electrical equipment group index, 3.6 percent in the vehicles and associated transport equipment group index and 26.0 percent in the optical, precision and medical instruments group index. During the mentioned period, there were some declines of 5.8 percent in the animal products group index and 0.3 percent in the footwear group index.

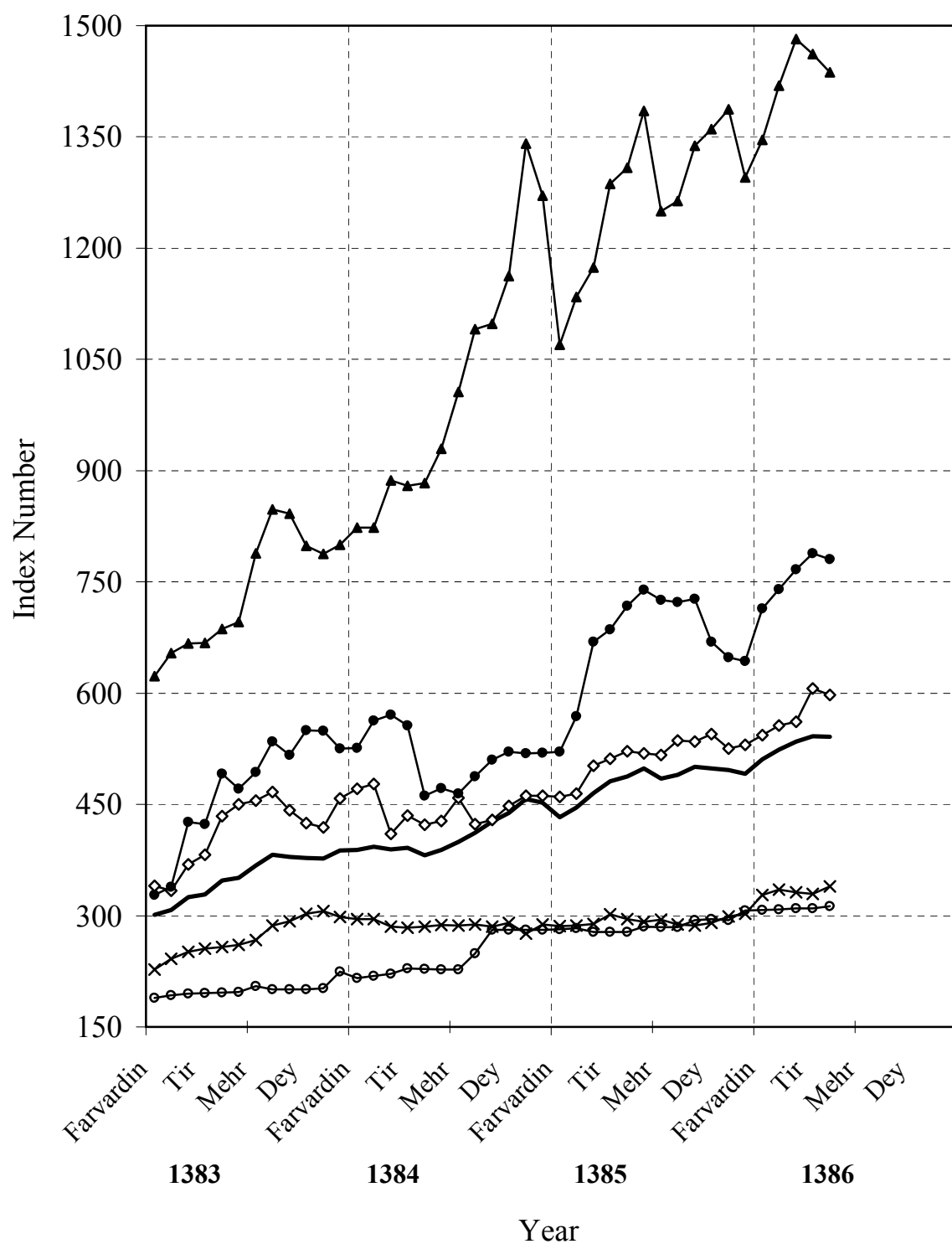
