Export Price Index in Iran

Shahrivar 1386

(1376 = 100)

The Export Price Index (**XPI**) went down 1.5 percent in Shahrivar 1386. Showing the index point of 533.0, the **XPI** was 6.9 percent higher than the similar month in 1385.

During the first six months of the current Iranian year, the **XPI** increased 13.3 percent compared to the similar period in 1385.

The **XPI** rose 13.9 percent during the last twelve months leading to Shahrivar 1386 compared with the similar preceding period.

The 1.5 percent decline in the **XPI**, in Shahrivar 1386, was mainly due to some decreases of 3.2 percent in the propane price index, 8.1 percent in the benzene price index, 4.1 percent in the zinc-oxide concentrate price index, 3.6 percent in the hot coil iron price index, 18.0 percent in the zinc-oxide price index, 3.2 percent in the butane price index, 1.7 percent in the copper price index, 6.9 percent in the jet fuel price index, 7.3 percent in the ammonia price index, 1.4 percent in the pistachio price index and 7.8 percent in each of the cumin and the aluminum price indices. In this month, the increase in the index prices of sheep assorted casing, hydrogenised oil, detergent powders, clothing, tar, resins and natural gums, hand-woven carpet, saffron, date, sulfur and raisin were considerable.

In Shahrivar 1386 compared to the similar month of the previous year, there were some increases of 16.5 percent in the vegetable products group index, 43.7 percent in the animal or vegetable fats and oils group index, 2.3 percent in the prepared foodstuffs, beverages and tobacco group index, 0.5 percent in the mineral products group index, 11.2 percent in the products of the chemical or allied industries group index, 1.1 percent in the plastics and articles thereof, rubber and articles thereof group index, 29.7 percent in the skins and leather and articles thereof group index, 88.3 percent in the wood and articles of wood group index, 10.0 percent in the textiles and textile articles group index, 8.7 percent in the articles of stone group index, 3.2 percent in the base metals and articles of base metal group index, 52.5 percent in the machinery and mechanical appliances, electrical equipment group index, 3.8 percent in the vehicles and associated transport equipment group index and 26.0 percent in the optical, precision and medical instruments group index. During the mentioned period, there were some declines of 1.9 percent in the animal products group index and 0.3 percent in the footwear group index.


