Export Price Index in Iran

Mehr 1386

(1376 = 100)

The Export Price Index (**XPI**) went up 4.5 percent in Mehr 1386. Showing the index point of 556.8, the **XPI** was 14.9 percent higher than the similar month in 1385.

During the first seven months of the current Iranian year, the **XPI** increased 13.5 percent compared to the similar period in 1385.

The **XPI** rose 13.4 percent during the last twelve months leading to Mehr 1386 compared with the similar preceding period.

In this month, the mentioned advance in the XPI was as a result of some increases of 13.6 percent in the propane price index, 14.3 percent in the copper price index, 13.7 percent in the butane price index, 5.8 percent in the zinc-oxide concentrate price index, 8.4 percent in the processed sheep skins price index, 1.9 percent in the hand-woven carpet price index, 6.7 percent in the sheep assorted casing price index, 9.1 percent in the tar price index, 17.4 percent in the cumin price index, 2.8 percent in the clothing price index, 3.1 percent in the jet fuel price index, 10.5 percent in the hydrogenised oil price index, 3.1 percent in the sulfur price index, 0.6 percent in the benzene price index, 3.7 percent in the zinc-oxide price index, 7.3 percent in the almond price index and 4.1 percent in the raisin price index. In this month, the index price of pistachio went down.

In Mehr 1386 compared to the similar month of the previous year, there were some increases of 4.0 percent in the animal products group index, 12.4 percent in the vegetable products group index, 47.5 percent in the animal or vegetable fats and oils group index, 0.1 percent in the prepared foodstuffs, beverages and tobacco group index, 22.8 percent in the mineral products group index, 14.1 percent in the products of the chemical or allied industries group index, 3.1 percent in the plastics and articles thereof, rubber and articles thereof group index, 43.5 percent in the skins and leather and articles thereof group index, 85.9 percent in the wood and articles of wood group index, 12.3 percent in the textiles and textile articles group index, 6.0 percent in the articles of stone group index, 12.2 percent in the base metals and articles of base metal group index, 52.5 percent in the machinery and mechanical appliances, electrical equipment group index, 8.2 percent in the vehicles and associated transport equipment group index and 26.0 percent in the optical, precision and medical instruments group index. In the same period, there was no change in the footwear group index.

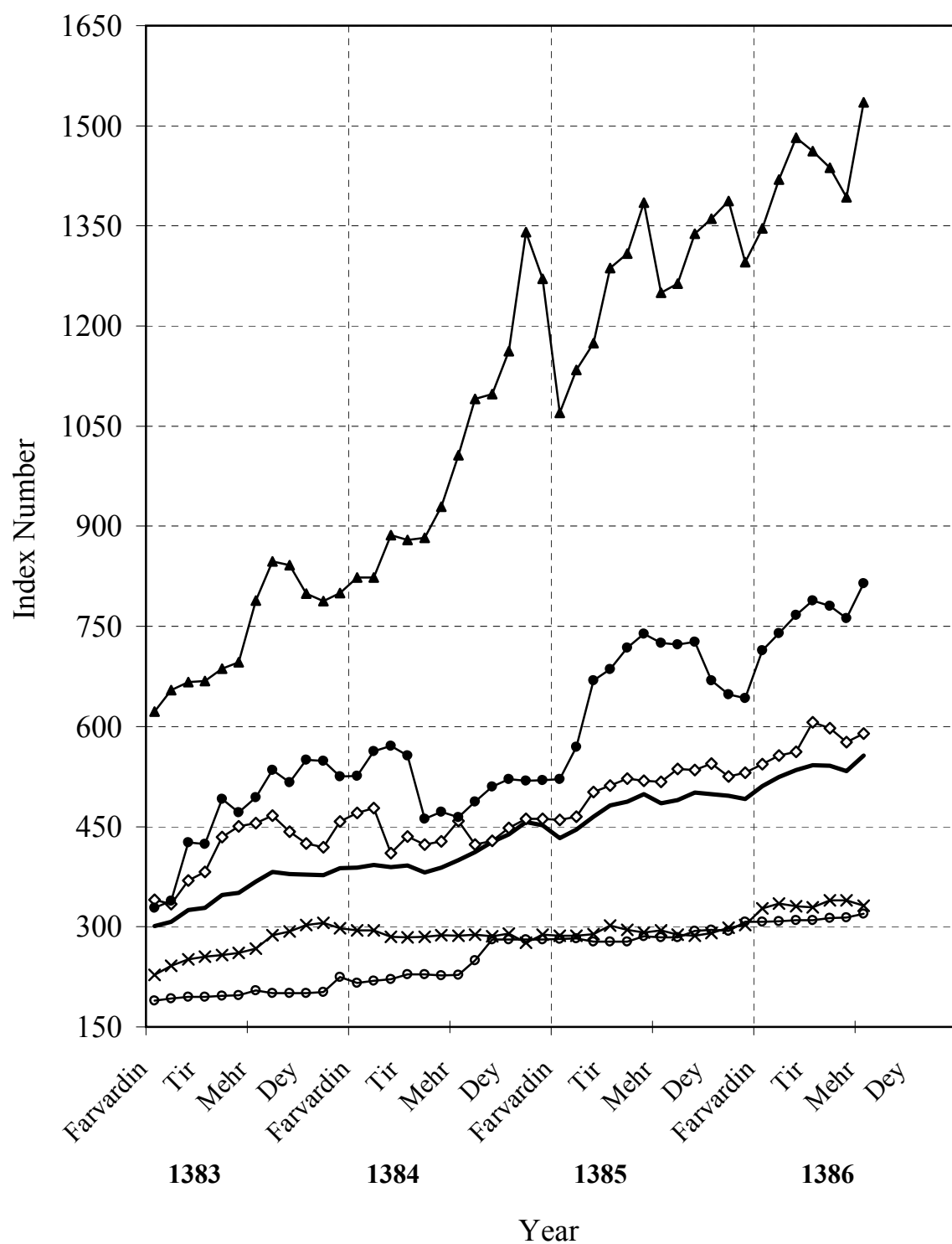
