Export Price Index in Iran

Aban 1387

(1376 = 100)

The Export Price Index (**XPI**) went down 13.6 percent* in Aban 1387. Showing the index point of 619.2, the **XPI** was 9.0 percent higher than the similar month in 1386.

During the first eight months of the current Iranian year, the **XPI** increased 25.5 percent compared to the similar period in 1386.

The **XPI** rose 24.0 percent during the last twelve months leading to Aban 1387 compared with the similar preceding period.

The 13.6 percent decline in the **XPI**, in Aban 1387, was mainly due to some decreases of 44.5 percent in the propane price index, 63.2 percent in the benzene price index, 95.2 percent in the sulfur price index, 45.4 percent in the butane price index, 38.0 percent in the copper price index, 10.6 percent in the caviar price index, 45.5 percent in the zinc-oxide concentrate price index, 4.9 percent in the hot coil iron price index, 30.3 percent in the ethylene price index, 7.6 percent in the processed sheep skins price index, 8.2 percent in the sheep assorted casing price index, 38.3 percent in the paraffin price index, 8.2 percent in the zinc-oxide price index, 21.8 percent in the almond price index, 27.3 percent in the aluminium price index, 5.6 percent in the hydrogenised oil price index and 2.2 percent in the tar price index. In this month, the advance in the index prices of hand-woven carpet, pistachio,


* The index is compiled by Rial prices and during the reported period compared to the previous month, the exchange rates of Dollar increased 2.8 percent and Euro decreased 5.8 percent.

ammonia, machine-made carpet, saffron, ice cream, footwear, macaroni, vinyl acetate, resins and natural gums, clothing, plywood and chipboard, tire, cement, wire, porcelain and ceramic, plastic products and glazed tile and ceramic were considerable.

In Aban 1387 compared to the similar month of the previous year, there were some increases of 6.6 percent in the animal products group index, 55.1 percent in the vegetable products group index, 28.8 percent in the animal or vegetable fats and oils group index, 19.1 percent in the prepared foodstuffs, beverages and tobacco group index, 32.8 percent in the products of the chemical or allied industries group index, 15.6 percent in the plastics and articles thereof, rubber and articles thereof group index, 57.1 percent in the wood and articles of wood group index, 36.1 percent in the textiles and textile articles group index, 19.0 percent in the footwear group index, 17.9 percent in the articles of stone group index, 20.6 percent in the base metals and articles of base metal group index, 12.0 percent in the machinery and mechanical appliances, electrical equipment group index and 14.5 percent in the optical, precision and medical instruments group index. During the mentioned period, there were some declines of 40.8 percent in the mineral products group index, 1.7 percent in the skins and leather and articles thereof group index and 2.9 percent in the vehicles and associated transport equipment group index.
