

Export Price Index in Iran

Esfand 1387

(1376 = 100)

The Export Price Index (**XPI**) went up 0.7 percent* in Esfand 1387. Showing the index point of 561.6, the **XPI** was 9.1 percent lower than the similar month in 1386.

On the average, the Export Price Index in 1387 rose 13.9 percent compared to the previous year.

The 0.7 percent advance in the **XPI**, in Esfand 1387, was mainly due to some increases of 26.9 percent in the benzene price index, 44.6 percent in the ammonia price index, 1.3 percent in the hand-woven carpet price index, 13.2 percent in the zinc-oxide concentrate price index, 1.6 percent in the pistachio price index, 6.4 percent in the sheep assorted casing price index, 9.4 percent in the vinyl acetate price index, 14.4 percent in the resins and natural gums price index, 4.1 percent in the ethylene price index, 5.0 percent in the cement price index, 1.3 percent in the saffron and macaroni price index each, and 0.8 percent in the machine-made carpet price index. In this month, the decrease in the index prices of processed sheep skins, butane, propane, sulfur, clothing and tar were considerable.


In Esfand 1387 compared to the similar month of the previous year, there were some increases of 47.9 percent in the vegetable products group index, 15.4 percent in the prepared foodstuffs, beverages and tobacco group index, 1.2 percent in the wood and articles of wood group index, 25.9 percent

* The index is compiled by Rial prices. During the reported period compared to the previous month, the exchange rate of Dollar increased 1.3 percent but Euro decreased 0.1 percent .

in the textiles and textile articles group index, 18.1 percent in the footwear group index, 13.6 percent in the articles of stone group index and 9.5 percent in the optical, precision and medical instruments group index. During the mentioned period, there were some declines of 5.7 percent in the animal products group index, 11.1 percent in the animal or vegetable fats and oils group index, 43.4 percent in the mineral products group index, 8.2 percent in the products of the chemical or allied industries group index, 3.9 percent in the plastics and articles thereof, rubber and articles thereof group index, 18.9 percent in the skins and leather and articles thereof group index, 26.6 percent in the base metals and articles of base metal group index, 20.8 percent in the machinery and mechanical appliances, electrical equipment group index and 2.2 percent in the vehicles and associated transport equipment group index.
