Producer Price Index in Iran

Shahrivar 1388

(1383 = 100)

The Producer Price Index **(PPI)** went down 0.6 percent in Shahrivar 1388. Showing the index point of 179.8, the **PPI** was 4.2 percent higher than the similar month in 1387.

During the first six months of the current Iranian year, the Producer Price Index rose 8.5 percent compared with the similar period in 1387.

The Producer Price Index increased 13.9 percent during the last twelve months leading to Shahrivar 1388, compared to the similar preceding period.

In Shahrivar, the agriculture, hunting and forestry group index decreased 4.6 percent, which was mainly attributed to the fall in the indices of "wheat", "clover", "patch vegetables", "garden vegetables", "fruits with seeds and tiny pits" and "farming of birds". In this group, the prices of "rice", "root vegetables", "half tropical fruits" and "farming of cattle, sheep and goats" moved up.

The fall in the index of "Persian Gulf fish" principally caused 1.2 percent decrease in the group index of fishing.

The manufacturing group index rose 0.7 percent.

The hotels and restaurants group index, the transport, storage and communications group index and the education group index went up 0.5 percent, 0.1 percent and 0.4 percent, respectively.

The health and social work group index rose 3.5 percent, which was mostly attributed to the rise in the indices of "hospital activities" and "medical and dental practice activities".

The other community, social and personal service activities group index increased 1.1 percent.


