Export Price Index in Iran

Ordibehesht 1389

The Export Price Index (**XPI**) virtually unchanged* in ordibehesht 1389.The index level of 200.5 was 15.2 percent higher than in Ordibehesht 1388.

During the first two months of the current Iranian year, the XPI increased 15.0 percent compared to the similar period in 1388.

The XPI has fallen 3.0 percent over the last twelve months.

The animal products group index decreased 1.0 percent, which was attributed to the decline of the index for sheep assorted casing.

The fall in the indices of pistachio, saffron, raisin, cumin and liquorice extract powder mostly resulted 4.2 percent decrease in the group index of vegetable products. In this group, the index for date went up.

As a result of rising in the indexes for sun flower oil and soya oil, the index for animal or vegetable fats and oils group advanced 2.0 percent.

The advance in the indexes of tomato puree, beverage, ice cream and fruit juice largely caused 2.0 percent rise in the group index of prepared foodstuffs, beverages and tobacco.

During Ordibehesht, the mineral products group index went up 1.8 percent which was mainly due to the increase in the indexes for paraffin, butane, iron stone, propane, cement, bentonite powder and barite powder.

The index for products of the chemical or allied industries group fell 10.7 percent. Decreases in the indexes for benzene, ammonia, methanole and

molybdenum-oxide were the major reasons for this decline. Within the mentioned group, increases in the indexes for paraxylene, shampoo and detergent powders were also considerable.

The plastics and articles thereof, rubber and articles thereof group index rose 0.2 percent.

The 4.0 percent increase in the group index of skins and leather and articles thereof was principally due to the rise of the index for processed sheep skin.

The wood and articles of wood group index and the textiles and textile articles group index increased 0.4 percent, each.

As a result of rising in the index for safety shoe, the index for footwear group went up 24.7 percent.

The articles of stone group index moved up 0.7 percent.

The index for base metals and articles of base metal group rose 8.7 percent. Increases in the indexes for hot coil iron, steel ingot and galvanized pipe mostly accounted for the current month advance of this group. In this group the index for aluminium ingot decreased.

The machinery and mechanical appliances, electrical equipment group index increased 1.1 percent.

The decrease in the index of tractor caused 5.4 percent decline in the vehicles and associated transport equipment group index.

The optical, precision and medical instruments group index moved up 2.0 percent, largely due to the increase of the index for syringe.


