Export Price Index in Iran

Khordad 1389

(1383 = 100)

The Export Price Index (**XPI**) virtually unchanged^{*} in Khordad 1389.The index level of 200.6 was 14.8 percent higher than in Khordad 1388.

During the first three months of the current Iranian year, the XPI increased 14.9 percent compared to the similar period in 1388.

The XPI has fallen 0.3 percent over the last twelve months.

The animal products group index decreased 1.6 percent, which was attributed to the decline of the index for sheep assorted casing.

The index for vegetable products group declined 0.3 percent.

As a result of rising in the indexes for sun flower oil and soya oil, the index for animal or vegetable fats and oils group advanced 2.0 percent.

The advance in the indexes for tomato puree, beverage, fruit juice, biscuit and wafer, non-cacao chocolate and ice cream largely caused 1.5 percent rise in the group index of prepared foodstuffs, beverages and tobacco.

During Khordad, the mineral products group index went down 2.7 percent which was mainly due to the decrease in the indexes for propane and butane. Within the mentioned group, increases in the indexes for paraffin, iron stone, cement, bentonite powder and barite powder were considerable.

The index for products of the chemical or allied industries group fell 6.2 percent. Decreases in the indexes for ammonia, paraxylene, molybdenum-oxide

and mono ethylene glycole were the major reasons for this decline. In this group, the indexes for benzene, detergent powders, paints and shampoo went up.

The plastics and articles thereof, rubber and articles thereof group index declined 0.2 percent.

The 2.1 percent increase in the group index of skins and leather and articles thereof was principally due to the rise in the index for processed sheep skin.

The wood and articles of wood group index and the textiles and textile articles group index increased 0.5 percent and 0.2 percent, respectively.

As a result of rising in the index for safety shoe, the index for footwear group went up 2.0 percent.

The articles of stone group index moved up 1.9 percent, largely due to the increases in the indexes for building stone, ceramic and tile.

The index for base metals and articles of base metal group rose 6.3 percent. Increases in the indexes for steel ingot, hot coil iron and galvanized pipe mostly accounted for the Khordad advance of this group. The index for aluminium ingot fell.

The increase in the index of cooler caused 1.1 percent advance in the machinery and mechanical appliances, electrical equipment group index.

The advance in the index for tractor mostly resulted in 10.8 percent rise in the vehicles and associated transport equipment group index. Within this group, decrease in the index for radiator for automobile was also noticeable.

The optical, precision and medical instruments group index moved up 2.0 percent, mainly due to the increase in the index for syringe.


