## **Export Price Index in Iran**

**Tir 1389**

**(1383 = 100)**

The Export Price Index (**XPI**) went down 1.9 percent in Tir 1389\* . The index level of 196.8 was 9.2 percent higher than in Tir 1388.

During the first four months of the current Iranian year, the XPI increased 13.5 percent compared to the similar period in 1388.

The XPI has risen 1.9 percent over the last twelve months.

The animal products group index increased 2.4 percent, which was attributed to the advance of the index for sheep assorted casing.

The fall in the indexes for pistachio, raisin and almond mostly resulted 2.1 percent decrease in the group index of vegetable products. In this group, the indexes for saffron and cumin went up.

As a result of rising in the index for soya oil, the index for animal or vegetable fats and oils group advanced 2.3 percent.

The prepared foodstuffs, beverages and tobacco group index increased 0.1 percent.

During Tir, the mineral products group index went down 5.7 percent which was mainly due to the decrease in the indexes for propane, butane and paraffin. In this group, the indexes for iron stone, zinc-oxide concentrate and cement increased.

The index for products of the chemical or allied industries group fell 3.4 percent. Decreases in the indexes for benzene, paraxylene and ammonia were

the major reasons for this decline. Within the mentioned group, increases in the indexes for molybdenum-oxide and methanole were considerable.

The plastics and articles thereof, rubber and articles thereof group index rose 0.8 percent.

The 18.9 percent increase in the group index of skins and leather and articles thereof was principally due to the rise in the index for processed sheep skin.

The wood and articles of wood group index and the textiles and textile articles group index increased 0.1 percent, each.

The footwear group index and the articles of stone group index moved up 0.2 percent and 0.1 percent, respectively.

The index for base metals and articles of base metal group declined 0.9 percent.

The increase in the index for cooler caused 1.1 percent advance in the machinery and mechanical appliances, electrical equipment group index.

The vehicles and associated transport equipment group index went up 2.4 percent, largely due to the increase in the indexes for tractor and radiator for automobile.

The optical, precision and medical instruments group index advanced 0.2 percent.

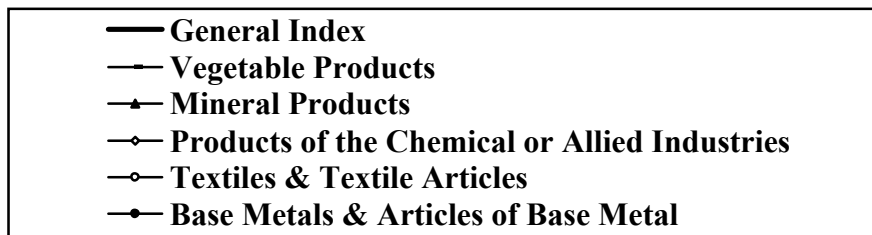
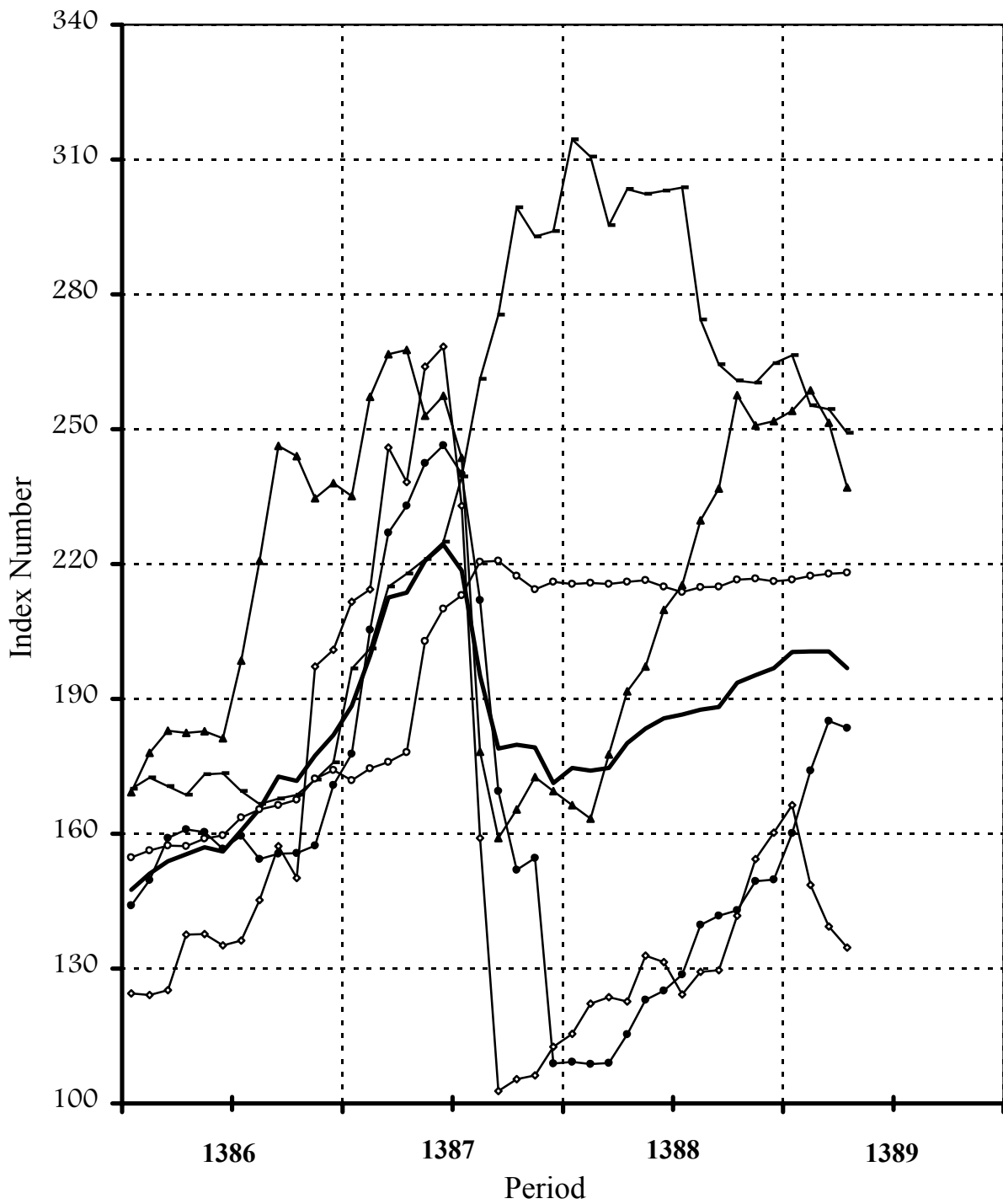
