Export Price Index in Iran

The Export Price Index (**XPI**) went up 0.7 percent in Aban 1389*. The index level of 209.1 was 11.5 percent higher than in Aban 1388.

During the first eight months of the current Iranian year, the XPI increased 11.4 percent compared to the similar period in 1388.

The XPI has advanced 10.6 percent over the last twelve months.

The animal products group index was unchanged.

The vegetable products group index went down 6.9 percent which was attributed to the decline in the indexes for saffron, pistachio and date. In this group, the indexes for raisin and cumin moved up.

Rises in the indexes for sunflower oil, soya oil and palm oil mainly accounted for the advance in the group index for animal or vegetable fats and oils by 6.6 percent.

The 1.8 percent increase in the group index of prepared foodstuffs, beverages and tobacco was principally due to the advanced in the indexes for tomato puree and fruit juice.

The mineral products group index rose 7.4 percent, mostly as a result of the advance in the indexes for propane, butane and zinc-oxide concentrate. Within the mentioned group, decreases in the indexes for iron stone, cement and paraffin were also considerable.

* The index is compiled by Rial prices and during the reported period compared to the previous month, the exchange rate of Dollar decreased 0.5 percent but the exchange rate of Euro was unchanged.

The group index for products of the chemical or allied industries rose 2.9 percent. Increases in the indexes for methanol, sulfur, ammonia, molybdenum-oxide and mono ethylene glycole were the major factors for this advance.

As a result of rising in the indexes for tires, rubber pipe, alkyd resin, poly ethylene and polyvinyl chloride, the group index for plastics and articles thereof, rubber and articles thereof went up 1.6 percent.

The advance in the index for processed sheep skin 14.7 percent increase in the group index for skins and leather and articles thereof.

The wood and articles of wood group index and the textiles and textile articles group index declined 0.2 percent and 0.5 percent, respectively.

The footwear group index was unchanged.

The articles of stone group index turned down 0.4 percent.

The group index for base metals and articles of base metal group fell 1.1 percent. Reductions in the indexes for hot coil iron, galvanized pipe and steel profile, were the main reasons for this decrease. Within this group, the indexes for aluminium ingot and ferro molybdenum went up.

The machinery and mechanical appliances, electrical equipment group index and the vehicles and associated transport equipment group index rose 0.1 percent, each.

The optical, precision and medical instruments group index was unchanged.

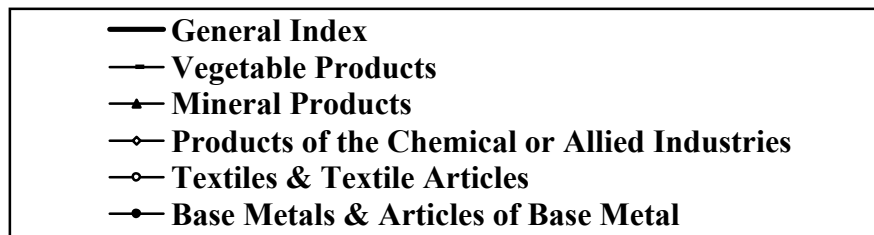
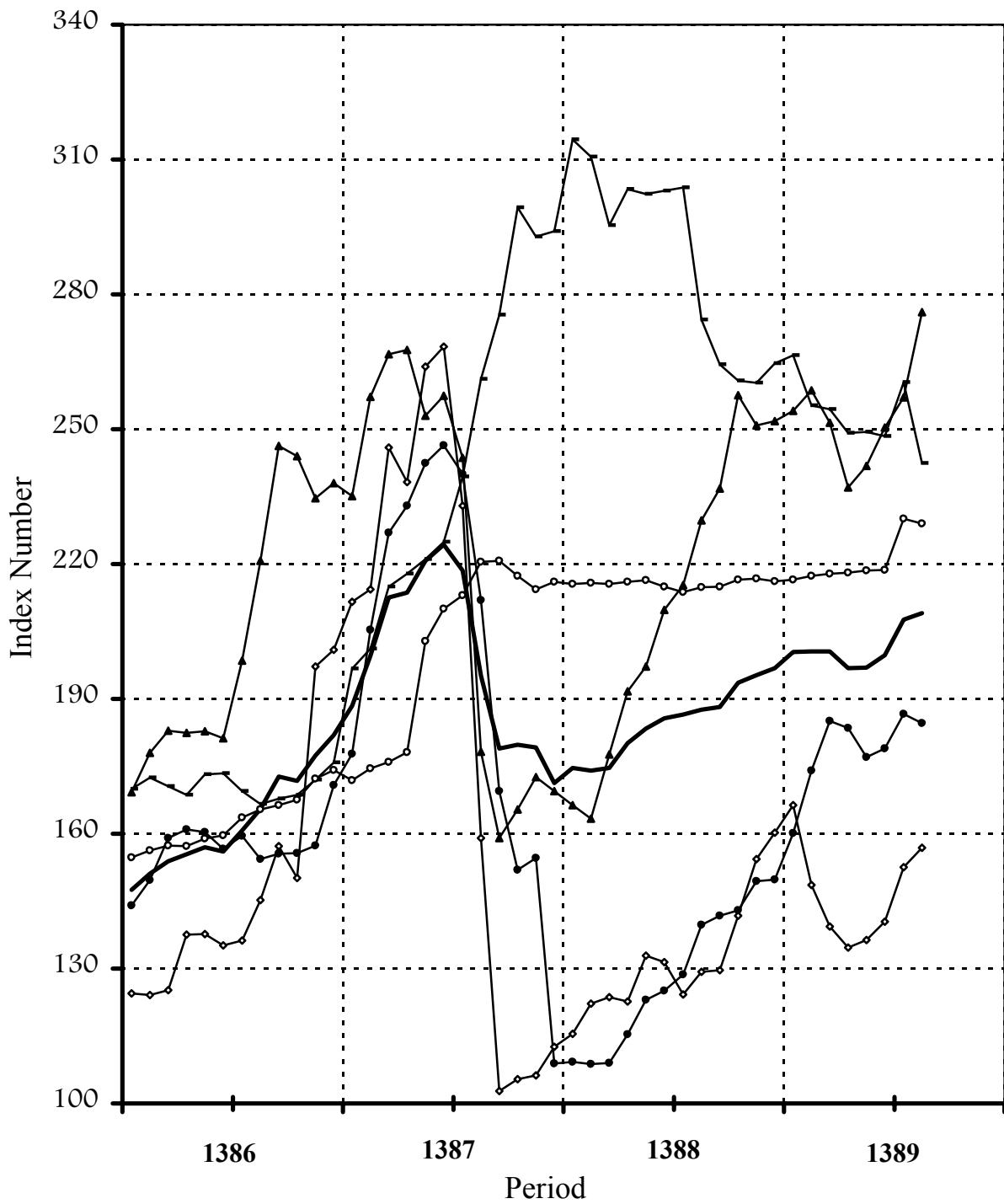
