### **Export Price Index in Iran**

### **Esfand 1390**

(1383 = 100)

The Export Price Index (**XPI**) went up 5.5 percent in Esfand 1390\* following a 4.2 percent rise in Bahman 1390. The index level of 260.4 was 22.2 percent higher than in Esfand 1389.

On average, the export price index in 1390 increased 14.2 percent compared to the previous year.

In Esfand, the animal products group index went up 1.1 percent mainly due to the advance in the index for sheep assorted casing.

The vegetable products group index rose 0.9 percent.

As a result of rising in the indexes for sunflower oil and soya oil, the group index for animal or vegetable fats and oils moved up 1.3 percent.

The group index for prepared foodstuffs, beverages and tobacco advanced 0.8 percent.

The 18.3 percent increase in the mineral products group index was principally attributed to the advances in the indexes for propane, butane, tar, paraffin wax, cement and bentonite powder.

The products of the chemical or allied industries group index increased 0.8 percent

During Esfand, rises in the indexes for polyethylene, motorcycle tires, melamine dishes, motorcycle and bicycle tubes and rubber pipe caused 1.9 percent

<sup>\*</sup> The index is computed on the Iranian Rial basis. In this month, the exchange rates of Dollar and Euro increased 1.2 percent and 2.0 percent, respectively.

increase in the group index of plastics and articles thereof, rubber and articles thereof. In this group, the index for polystyrene declined.

As a result of decreasing in the index for processed sheep skin, the group index for skins and leather and articles thereof fell 6.7 percent.

The wood and articles of wood group index went up 0.3 percent.

The group index for textiles and textile articles rose 2.1 percent. Increases in the indexes for hand-woven carpet and machine-made carpet were the major reasons for this advance. In the mentioned group, the index for polypropylene gunny decreased.

Increase in the index of safety shoe, particularly accounted for the advance in the footwear group index by 2.0 percent.

The articles of stone group index moved up 2.6 percent mostly due to the rises in the indexes for tile and building stone.

The base metals and articles of base metal group index fell 1.1 percent. Decrease in the index for hot coil iron was the major factor for this decline. In this group, increases in the indexes for steel profile, cathode copper and ferro molybdenum were also considerable.

The machinery and mechanical appliances, electrical equipment group index advanced 0.8 percent.

The vehicles and associated transport equipment group index increased 1.1 percent mostly as a result of the rise in the index for radiator for automobile.

The optical, precision and medical instruments group index was unchanged.


