Producer Price Index in Iran

Dey 1396

(1390 = 100)

The Producer Price Index (PPI) went up 1.1 percent in Dey 1396 following an increase of 1.5 percent in Azar 1396. The index level of 258.8 was 10.9 percent higher than in Dey 1395.

For the first 10 months of 1396, the PPI edged up 10.1 percent, compared to the similar period in 1395.

This index moved up 9.9 percent for the 12 months ended in Dey 1396.

Agriculture, forestry and fishing: In Dey, a 0.1-percent decrease in the prices of this group can be traced to the falls in the indices for corn, leaf vegetables, oranges, kiwifruit, egg and "fishing and aquaculture". In contrast, prices for potatoes, tangerines, grapefruits and pomegranate went up.

Manufacturing: The Manufacturing group index moved up 2.3 percent, which was mostly due to the rises in the indices for dried pistachio, dried tea, livestock and poultry feed, carpets and insulation of car, upper leather, cardboard, jet propulsion fuel (type 4), tar, methanol, acetic acid, propylene, exported methanol, exported ammonia, manufacture of plastics and synthetic rubber in primary forms (domestic use), musculoskeletal medicines, refractory brick, earthen block, round bar, galvanized pipe, seamless pipes, cast-iron ingot, iron profile, staple copper, lead and zinc products, casting of metals, conex,

radiator, AC transformer and surge protector, copper wire, cable, fluorescent induction lamp, ventilator and tractor. On the contrary, prices for slaughter poultry, chocolate, sulphur, iron beam, copper concentrate, transmission tower, metal cans and transformer declined.

Services: Increases in the index of dental services mainly led to 0.2 percent rise in the services group.
