

Export Price Index in Iran

Dey 1397

(1390 = 100)

The Export Price Index (**XPI**) decreased 3.4 percent in Dey 1397. The index level of 723.5 was 140.7 percent higher than in Dey 1396.

During the first ten months of the current Iranian year, the XPI rose 160.1 percent compared to the similar period in 1396.

The XPI has advanced 140.1 percent over the past twelve months.

In Dey, the animal products group index moved down 0.8 percent, while the vegetable products group index moved up 0.8 percent.

The animal or vegetable fats and oils group index turned down 3.4 percent, over this month.

The prepared foodstuffs, beverages and tobacco group index went down 1.0 percent, largely due to the decreases in the prices for biscuit and wafer, tomato paste, cake, ice cream, and non-cacao chocolate.

During the mentioned month, the group index for mineral products fell 6.4 percent. Declines in the prices for propane, butane, industrial oil, paraffin wax, cement, engine oil, copper concentrate, and bitumen were the major reasons for this decline.

The products of the chemical or allied industries group index turned down 3.9 percent, largely due to the decreases in the prices for ammonia, urea fertilizer, mono ethylene glycol, "detergent powders and liquids", methanol, styrene, molybdenum oxide, and dodecyl benzene.

The 4.8 percent decrease in the plastics and articles thereof, rubber and articles thereof group index was led by declines in the prices for high density polyethylene, low density polyethylene, motorcycle tire, and plastic hoses.

During this month, the group index for skins and leather and articles thereof decreased 1.1 percent. In contrast, the group index for wood and articles of wood increased 2.3 percent

In Dey, the textiles and textile articles group index moved down 4.3 percent, which was mainly due to the fall in the price for hand-woven carpet.

The footwear group index went down 1.2 percent, largely due to the decrease in the price for "sandal with uppers of rubber or plastics".

The articles of stone group index dropped 2.0 percent over this month. The fall was driven by decreasing prices for "tile and ceramic", and float glass.

As a result of decreasing in the prices for zinc ingot, hot coil iron, ferromolybdenum, iron beam, and rebar, the base metals and articles of base metal group index decreased 1.3 percent.

Falls in the prices for gas water heaters, air cooler, and cable caused 1.9 percent decline in the machinery and mechanical appliances, electrical equipment group index.

The vehicles and associated transport equipment group index rose 2.7 percent in Dey, mainly due to the increase in the price for tractor while decrease in the price for car radiator was also considerable.

Export Price Index in Iran (1390=100)


