## **Producer Price Index In Iran**

Tir 1381 (1376 = 100)

The Producer Price Index **(PPI)** went up by 1.9% in Tir 1381. Showing the index point of 208.3, the **PPI** was 12.4% higher than the similar month in 1380.

During the first four months of the current Iranian year, the producer price index rose by 11.7% compared to the similar period in 1380.

The **PPI**, on the average, increased by 11.1% during the last twelve months leading to Tir 1381 compared with the similar preceding period.

In this month, among the major groups, the agriculture, animal husbandry and forestry group index went up by 2.1% which was attributed to the increase in the prices of wheat, clover, patch and garden vegetables, fruits with seeds and stones and poultry. In this group the prices of straw, fresh date and egg decreased.

The fishing group index and the repairing of motor vehicles group index went down by 0.4% and 0.4%, respectively.

The 11.4% decrease in the group of mining and quarrying was due to the decline in the prices of coal and non – metal ores .

The manufacturing group index went up by 1.7% which was attributed to the increase in the prices of chicken, exported shoes, scouring powder, tile, ceramic and structural ceramic products, plaster, asphalt and iron and steel. In this group the price of copper and its products decreased.

The electricity, gas and water supply index group and the education group index went up by 0.2% and 0.2%, respectively.

The 1.6% increase in the group of hotels and restaurants was due to the rise in the prices of restaurants and buffet .

The advance in the prices of scheduled passenger land transport and taxi operation caused 1.0% rise in the group of transport, storage and communications .

The financial intermediation group index went up by 2.8% which was attributed to the increase in the price of service charge of stock exchange.

The 3.0% increase in the group of real estate, renting and business activities was due to the rise in the price of real estate and renting.

The health and social work group index and the other community, social and personal service activities went up by 5.5% and 3.5%, respectively.
