Producer Price Index in Iran

Ordibehesht 1382

(1376 = 100)

The Producer Price Index (PPI) went up 1.1 percent in Ordibehesht 1382. Showing the index point of 232.9, the PPI was 15.0 percent higher than the similar month in 1381.

During the first two months of the current Iranian year, the Producer Price Index rose 14.9 percent compared to the similar period in 1381.

The PPI, on the average, increased 14.0 percent during the last twelve months leading to Ordibehesht 1382 compared with the similar preceding period.

In this month, the agriculture, animal husbandry and forestry group index went down 0.9 percent.

The 10.1 percent increase in the group index of fishing was due to the rise in the prices of the Caspian Sea fish.

The mining and quarrying group index and the education group index remained unchanged.

The manufacturing group index went up 1.1 percent which was attributed to the increase in the prices of dairy products, hand-made carpets and rugs, exported wearing apparel, kitchen cabinet, motor oil, bricks, cement, iron and steel, press machine, brake lining and gold coin. In this group the prices of exported P.V.C and lamps decreased.

The electricity, gas and water supply group index, the repairing of motor vehicles group index and the hotels and restaurants group index increased 15.7 percent, 1.0 percent and 1.7 percent, respectively.

The advance in the prices of domestic goods transport via railways, transport of passengers by bus, taxi agency fare, urban minibus and taxi fare and urban telephone conversation fee caused 1.2 percent rise in the group index of transport, storage and communications.

The 6.9 percent increase in the group index of financial intermediation was due to the rise in the prices of third party insurance and service charge of stock exchange.

The real estate, renting and business activities group index, the health and social work group index and the other community, social and personal service activities group index went up 1.2 percent, 3.5 percent and 0.3 percent, respectively.
