

Producer Price Index in Iran

Esfand 1382

(1376 = 100)

The Producer Price Index (**PPI**) went up 1.1 percent in Esfand 1382. Showing the index point of 260.1, the **PPI** was 14.5 percent higher than the similar month in 1381.

On the average, the Producer Price Index in 1382, rose 15.6 percent compared to the previous year.

In this month the agriculture, animal husbandry and forestry group index increased 0.3 percent.

The fishing group index went up 2.3 percent, which was attributed to the rise in the prices of Persian Gulf fish.

The mining and quarrying group index, the electricity, gas and water supply group index and the education group index remained unchanged.

The manufacturing group index increased 0.5 percent.

The repairing of motor vehicles group index and the hotels and restaurants group index rose 2.4 percent and 0.8 percent, respectively.

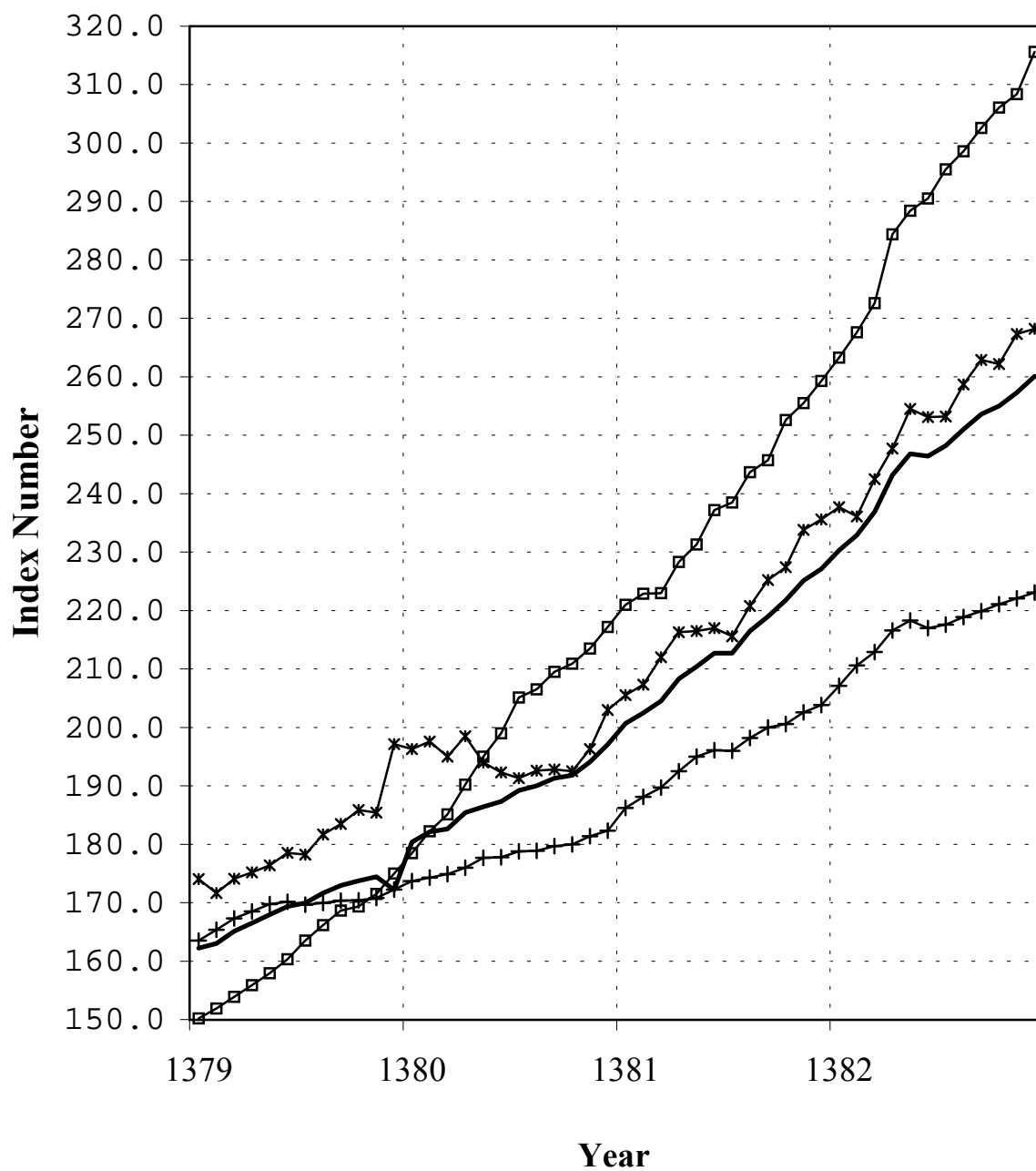
The advanced in the price of transport of passengers by bus caused 1.5 percent increase in the group index of transport, storage and communication.

The 3.8 percent rise in the group index of financial intermediation was due to the increase in the price of service charge of stock exchange.

The real estate, renting and business activities group index and the health and social work group index went up 2.7 percent and 0.3 percent, respectively.

The other community, social and personal service activities group index increased 6.1 percent, which was attributed to the rise in the cost of funeral.
