## **Export Price Index in Iran**

Ordibehesht 1386

(1376 = 100)

The Export Price Index (**XPI**) went up 2.5 percent in Ordibehesht 1386. Showing the index point of 524.0, the **XPI** was 17.5 percent higher than the similar month in 1385.

During the first two months of the current Iranian year, the **XPI** increased 17.7 percent compared to the similar period in 1385.

The **XPI** rose 18.2 percent during the last twelve months leading to Ordibehesht 1386 compared with the similar preceding period.

The 2.5 percent advance in the **XPI** , in Ordibehesht 1386, was mainly due to some increases of 8.6 percent in the propane price index, 5.5 percent in the copper price index, 9.0 percent in the butane price index , 49.2 percent in the zinc-oxide price index, 1.3 percent in the hand-woven carpet price index, 5.6 percent in the processed sheep skins price index, 2.7 percent in the hot coil iron price index, 17.3 percent in the saffron price index, 29.5 percent in the plywood and chipboard price index, 1.4 percent in the pistachio price index, 3.8 percent in the jet fuel price index, 5.3 percent in the plastic products price index, 6.5 percent in the glazed tile and ceramic price index, 15.5 percent in the almond price index, 1.3 percent in the sheep assorted casing and ethylene and propylene prices index each , and

4.2 percent in the raisin price index. In this month, the decline in the index prices of macaroni, ammonia, biscuit and wafer and cumin were considerable.

In Ordibehesht 1386 compared to the similar month of the previous year, there were some increases of 4.0 percent in the animal products group index, 16.8 percent in the vegetable products group index, 21.0 percent in the animal or vegetable fats and oils group index, 3.7 percent in the prepared foodstuffs, beverages and tobacco group index, 25.1 percent in the mineral products group index, 19.8 percent in the products of the chemical or allied industries group index, 5.7 percent in the plastics and articles thereof, rubber and articles thereof group index, 7.6 percent in the skins and leather and articles thereof group index, 103.1 percent in the wood and articles of wood group index, 8.9 percent in the textiles and textile articles group index, 0.3 percent in the footwear group index, 11.6 percent in the articles of stone group index, 30.0 percent in the base metals and articles of base metal group index, 52.5 percent in the machinery and mechanical appliances, electrical equipment group index and 3.9 percent in the vehicles and associated transport equipment group index. In the same period, there was no change in the optical, precision and medical instruments group index.


