Producer Price Index in Iran

Esfand 1386

(1376 = 100)

The Producer Price Index (**PPI**) went up 2.3 percent in Esfand 1386. Showing the index point of 452.8, the **PPI** was 20.1 percent higher than the similar month in 1385.

On average, the Producer Price Index in 1386 increased 16.8 percent compared to the previous year.

In Esfand, the agriculture, animal husbandry and forestry group index went up 2.3 percent, which was mainly attributed to the rise in the indices of “leaf vegetables”, “exported pistachio”, “live animals and milk”, “poultry” and “animal fertilizer”. In this group, the price of “egg” declined.

The advance in the indices of “Iranian river fish” and “Persian Gulf fish” mostly caused 5.1 percent increase in the group index of fishing. In this group, the price of “Caspian Sea fish” fell.

The mining and quarrying group index moved up 3.2 percent.

As a result of rising in the indices of “fresh meat”, “exported processed sheep skin”, “tomato puree (domestic use)”, “hand-woven carpet and rug”, “footwear”, “paper and cardboard”, “tar (domestic use)”, “P.V.C (domestic use)”, “exported benzene”, “exported propane”, “exported butane”, “exported ammonia”, “plastic in primary forms and synthetic rubber”, “liquid scouring”, “earthen brick”, “iron sheets”,

“iron rod”, “copper wire”, “exported copper”, “aluminum ingot”, “pure aluminum”, “electric motors”, copper cable”, “exported wire and cable” and “vans”, the manufacturing group index went up 3.0 percent. In this group, the price of “methanol” decreased.

The electricity, gas and water supply group index moved down 0.1 percent.

The repairing of motor vehicles group index and the hotels and restaurants group index increased 2.8 percent and 3.8 percent, respectively.

The advance in the index of “transport of passengers by bus” principally caused 1.5 percent rise in the group index of transport, storage and communications group index.

The financial intermediation group index fell 0.3 percent.

The 1.9 percent increase in the group index of real estate, renting and business activities was principally due to the advance in the price of “constructional services”.

The education group index had no change.

The health and social work group index and the other community, social and personal service activities moved up 1.2 percent and 2.1 percent, respectively.

Producer Price Index in Iran (1376 = 100)

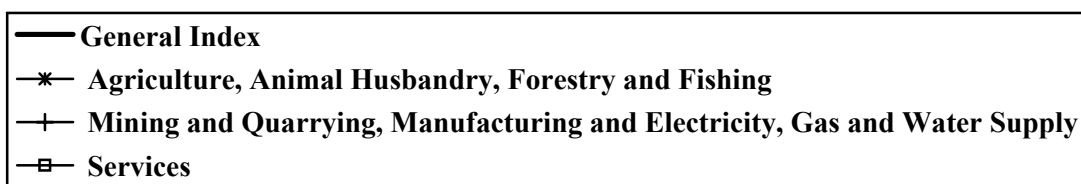
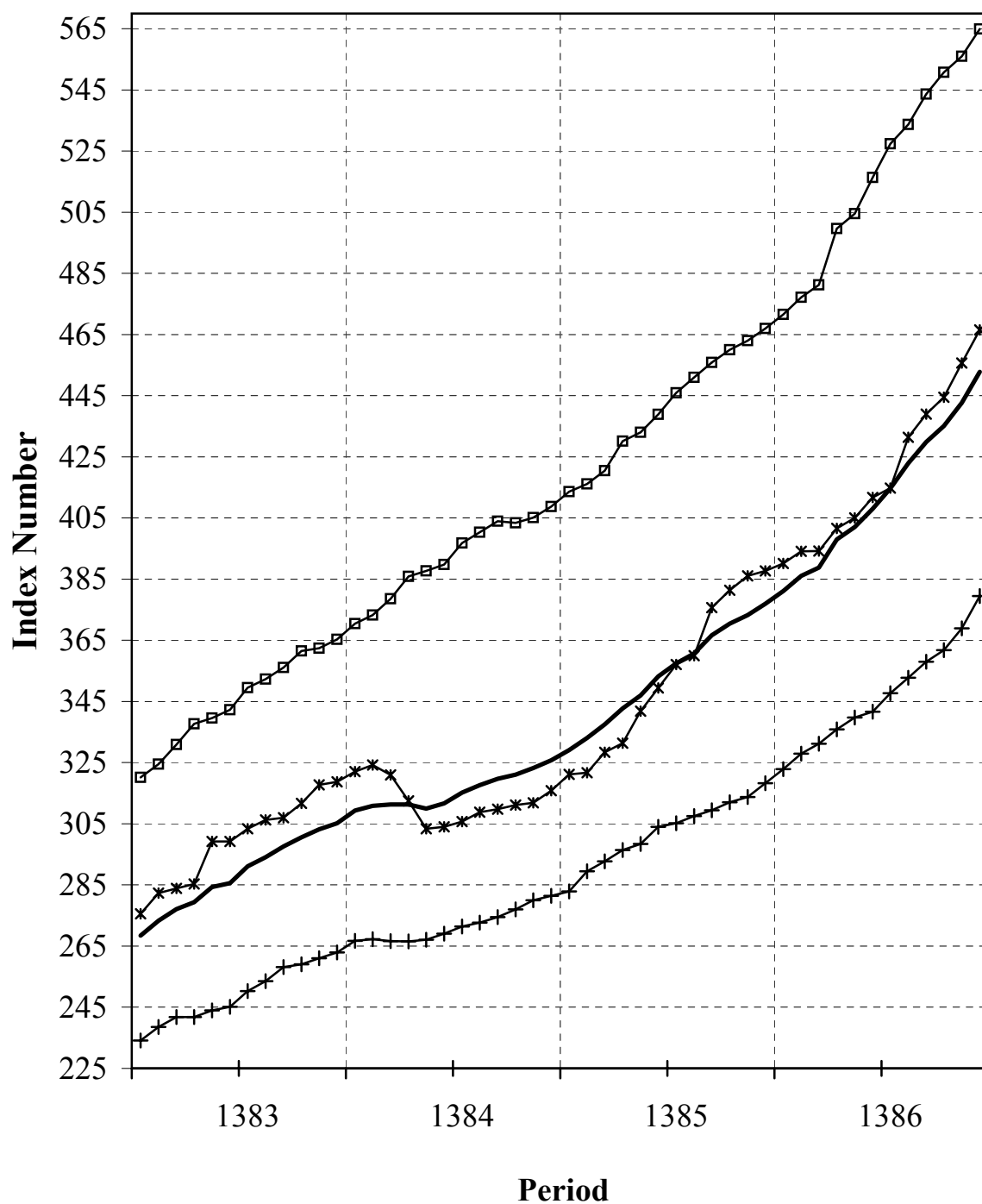
