

Producer Price Index in Iran

Tir 1387

(1376 = 100)

The Producer Price Index (**PPI**) went up 2.5 percent in Tir 1387. Showing the index point of 488.5, the **PPI** was 22.7 percent higher than the similar month in 1386.

During the first four months of the current Iranian year, the Producer Price Index rose 22.1 percent compared to the similar period in 1386.

The Producer Price Index increased 19.0 percent during the last twelve months leading to Tir 1387, compared with the similar preceding period.

In Tir, the agriculture, animal husbandry and forestry group index went up 2.5 percent, which was mainly attributed to the rise in the indices of “wheat”, “barley”, “straw”, “lucerne”, “fruits with seeds and pits”, and “poultry“. In this group, the prices of “potato (domestic use)”, “date”, “live animals and milk” and “honey” declined.

The advance in the index of “Persian Gulf fish” mostly caused 2.3 percent increase in the group index of fishing.

The mining and quarrying group index moved up 3.1 percent, which was principally due to the advance in the index of “gravel and sand”.

As a result of rising in the indices of “chicken”, “tomato puree (domestic use)”, “dairy products”, “bread”, “confection”, “macaroni”, “footwear”, “wooden furniture”, “carton and paper board”, “motor oil”, “benzene (domestic use)”, “exported butane”, “exported ammonia”, “plastics in primary forms and synthetic rubber”, “scouring

products”, “bricks”, “cement”, “asphalt”, “iron beam”, “iron rod”, “copper wire”, “metal structures”, “steel radiator”, “car spring”, “dizel generator”, “tap”, “gas oven”, “lamps”, “brake lining”, and “furniture”, the manufacturing group index went up 3.0 percent. In this group, the prices of “exported processed skin”, “exported sulfur”, “exported benzene” and “exported copper” fell.

The electricity, gas and water supply group index, the repairing of motor vehicles group index and the hotels and restaurants group index increased 0.6 percent, 1.8 percent and 2.4 percent, respectively.

The transport, storage and communications group index and the education group index had no change.

The 6.6 percent rise in the group index of financial intermediation was mainly attributed to the increase in the price of “third party insurance”.

The advance in the index of “constructional services” mostly caused 2.1 percent rise in the group index of real estate, renting and business activities.

The health and social work group index and the other community, social and personal service activities group index moved up 4.8 percent and 1.0 percent, respectively.

Producer Price Index in Iran (1376 = 100)



