## **Producer Price Index in Iran**

**Aban1387**

**(1376 = 100)**

The Producer Price Index (**PPI**) went up 0.2 percent in Aban 1387. Showing the index point of 523.2, the **PPI** was 23.7 percent higher than the similar month in 1386.

During the first eight months of the current Iranian year, the Producer Price Index rose 23.6 percent compared with the similar period in 1386.

The Producer Price Index increased 21.9 percent during the last twelve months leading to Aban 1387, compared to the similar preceding period.

In Aban, the agriculture, animal husbandry and forestry group index went up 2.3 percent, which was mainly attributed to the rise in the indices of "rice", "sesame seed", "potato (domestic use)", "sugar beet", "garden vegetables", "leaf vegetables", "lucerne", "fruits with seeds and pits", "dried fruits", "saffron (domestic use)", "exported saffron", "live animals and milk", "poultry" and "egg". In this group, the prices of "wild cotton", "patch vegetables", "root vegetables", "citrus" and "cotton" fell.

The advance in the index of "Caspian Sea fish" mostly caused 4.2 percent increase in the group index of fishing. In this group, the price of "Persian Gulf fish" moved down.

The mining and quarrying group index declined 5.1 percent.

The manufacturing group index went down 1.9 percent, which was principally due to the fall in the indices of "exported processed sheep skin", "exported caviar",

"polyester fiber", "hand-woven carpets and rugs (domestic use)", "exported sulfur", "exported benzene", "exported propane", "exported butane", "plastics in primary forms and synthetic rubber", "iron and steel", "copper wire", "exported copper", "pure aluminum" and "wire and cable". In this group, the prices of "chicken", "tomato puree (domestic use)", "cotton seed cake", "bread", "exported hand-woven carpets and rugs ", "exported machine-woven carpets and rugs", "overcoat", "exported shoes", "motor oil", "industrial oil", "exported ammonia", "medicine", "gas heater" and "batteries" went up.

The electricity, gas and water supply group index had no change.

The repairing of motor vehicles group index moved up 1.7 percent.

The 1.6 percent advance in the group index of hotels and restaurants was mostly due to the increase in the index of "restaurants and buffets".

As a result of rising in the index of "transport of passengers by domestic and foreign flights", the transport, storage and communications group index went up 1.4 percent.

The financial intermediation group index decreased 3.6 percent.

The real estate, renting and business activities group index rose 1.4 percent.

The education group index moved up 3.5 percent, which was mainly attributed to the increase in the index of "tuition fees of private schools".

The health and social work group index and the other community, social and personal service activities group index rose 0.8 percent and 0.5 percent, respectively.

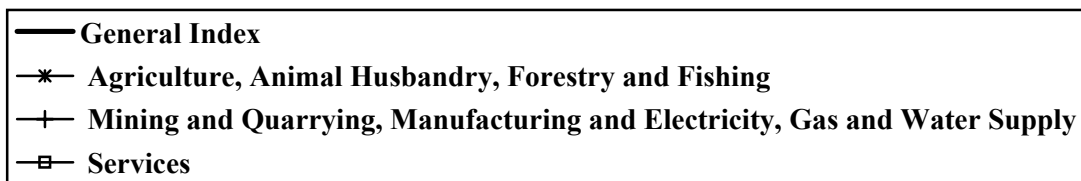
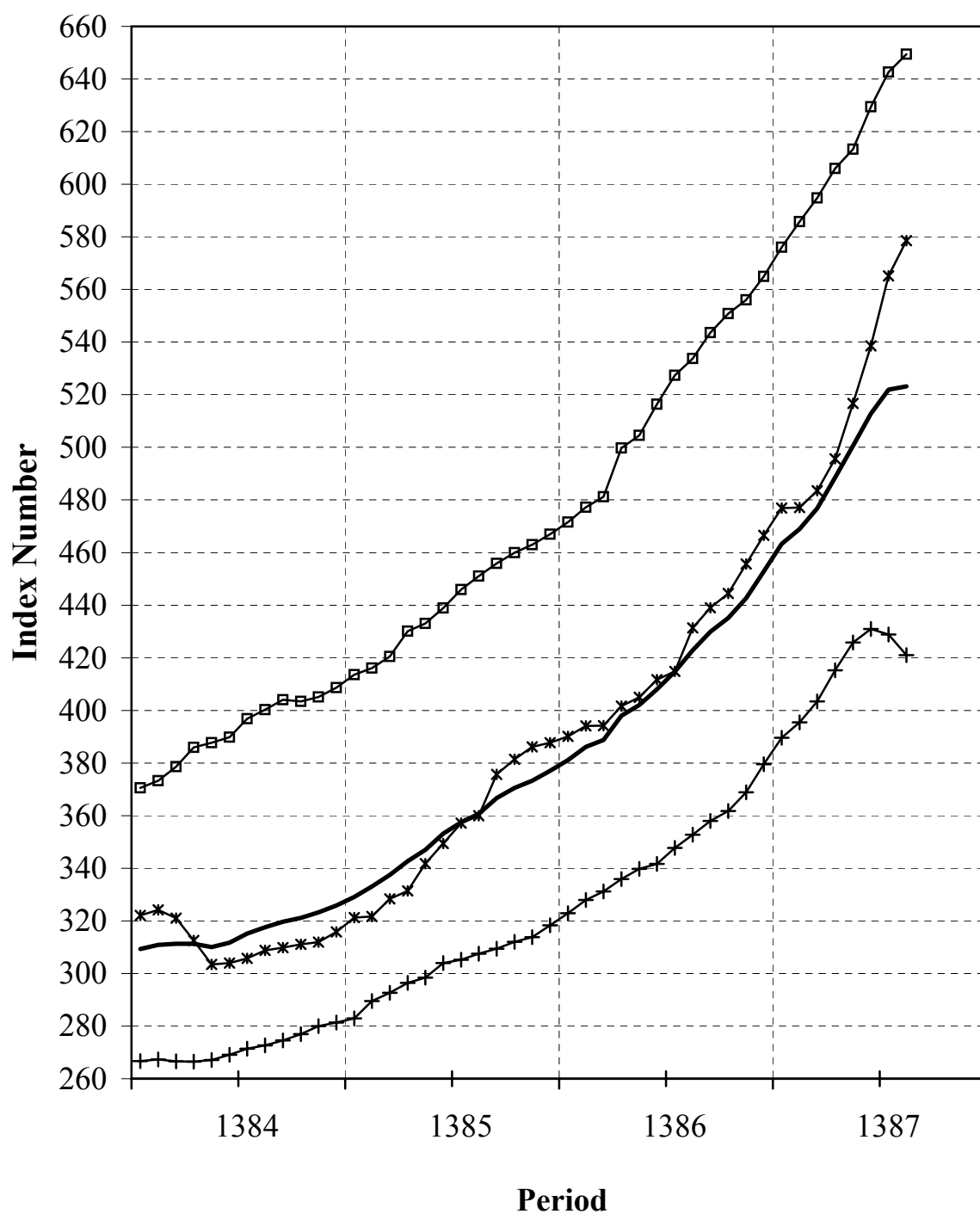
