Export Price Index in Iran

Tir 1388

(1383 = 100)

The Export Price Index (**XPI**) went up 3.1 percent* in Tir 1388. Showing the index point of 180.2, the **XPI** was 15.7 percent lower than the similar month in 1387.

During the first four months of the current Iranian year, the **XPI** decreased 13.6 percent compared to the similar period in 1387.

The **XPI** rose 5.3 percent during the last twelve months leading to Tir 1388 compared with the similar preceding period.

In Tir, the animal products group index rose 2.9 percent, largely as a result of the increase in the index of "sheep assorted casing".

The vegetable products group index increased 2.7 percent, mainly due to the advance of the indices for "saffron", "pistachio", "date" and "raisin". In this group, the price of "natural gums" went down.

The fall in the indices of "soya oil", "sun flower oil" and "palm oil" caused 2.8 percent decrease in the group index of animal or vegetable fats and oils.

The 1.6 percent increase in the group index of prepared foodstuffs, beverages and tobacco was mainly due to the rise in the indices of "beverage", "tomato puree ","non-cacao chocolate", "biscuit and wafer" and "ice cream".

The advance in the indices of "butane", "tar", "paraffin", "propane", "cement" and "zinc-oxide concentrate" mostly caused 7.9 percent rise in the group index of mineral products.

The products of the chemical or allied industries group index declined 0.7 percent.

^{*} The index is compiled by Rial prices and during the reported period compared to the previous month, the exchange rates of Dollar and Euro increased 2.0 percent and 2.1 percent, respectively.

The plastics and articles thereof, rubber and articles thereof group index went up 2.6 percent, which was principally attributed to the increase in the indices of "poly ethylene", "poly vinyl chloride", "motor cycle tires" and " rubber pipe".

The skins and leather and articles thereof group index rose 2.1 percent, largely due to the increase of the index for "processed sheep skin".

The wood and articles of wood group index had no change.

The textiles and textile articles group index moved up 0.2 percent.

As a result of rising in the index of "safety shoes", the footwear group index went up 2.1 percent.

The articles of stone group index rose 0.2 percent.

The increase in the indices of "hot coil iron", "aluminium ingot", "steel profile", "steel ingot" and "cathode copper" mostly resulted in 5.9 percent rise in the base metals and articles of base metal group index.

The increase in the index of "water cooler" caused 1.2 percent rise in the group index of machinery and mechanical appliances, electrical equipment.

The decline in the index of "tractor" caused 1.4 percent decrease in the vehicles and associated transport equipment group index. In this group, the price of "radiator for automobile" went up.

The optical, precision and medical instruments group index increased 1.2 percent, mainly due to the advance in the index in "syring".


