Producer Price Index in Iran

Tir 1389

(1383 = 100)

The Producer Price Index (PPI) went up 0.6 percent in Tir 1389. The index level of 194.9 was 9.0 percent higher than in Tir 1388.

For the first four months of 1389, the Producer Price Index rose 10.2 percent, compared to the similar period in 1388.

The Producer Price Index has advanced 7.5 percent over the last twelve months.

In Tir, the agriculture, hunting and forestry group index rose 2.3 percent, which was mainly attributed to the rise in the indices for lucerne, garden vegetables, fruits with seeds, fruits with tiny pits, farming of cattle, sheep and goat, poultry and honey. In this group, the prices for wheat produced by dry farming, barley, patch vegetables, root vegetables and egg moved down.

The advance in the index for Persian Gulf fish principally caused 7.3 percent increase in the group index for fishing.

The manufacturing group index fell 0.2 percent.

The hotels and restaurants group index moved up 0.6 percent.

The transport, storage and communications group index decreased 0.2 percent.

The education group index rose 0.3 percent.

The 1.4 percent rise in the group index for health and social work was mostly due to the increase in the index for medical and dental practice activities.

The other community, social and personal service activities group index moved up 1.3 percent which was principally attributed to the increase in the indices for out of school lesson in swimming and body building.


