Export Price Index in Iran

Khordad 1390

The Export Price Index (**XPI**) went up 2.1 percent in Khordad 1390* following a 5.3 percent rise in Ordibehesht 1390. The index level of 237.6 was 18.4 percent higher than in Khordad 1389.

During the first three months of the current Iranian year, the XPI increased 14.9 percent compared to the similar period in 1389.

The XPI has advanced 11.2 percent over the last twelve months.

In Khordad, the animal products group index increased 0.7 percent.

The 2.6 percent advance in the group index of vegetable products was largely due to the increases in the indexes of saffron, pistachio, cumin, date and almond. In this group, the index for raisin went down.

The group index for animal or vegetable fats and oils went up 5.0 percent mostly as a result of the rises in the indexes for sun flower oil, soya oil and palm oil.

The prepared foodstuffs, beverages and tobacco group index moved up 3.1 percent. Increases in the indexes for tomato paste, beverage, fruit juice, ice cream, buscuit and wafer, macaroni and cake were the major factors for the mentioned advance.

Decreases in the indexes of propane and butane caused 1.4 percent decline in the group index of mineral products. Within the mentioned group, the indexes for tar, paraffin, cement, bentonite powder and barite powder went up.

^{*} The index is compiled by Rial prices and during the reported period compared to the previous month, the exchange rates of Dollar and Euro increased 5.0 percent and 4.0 percent, respectively.

During Khordad, the products of the chemical or allied industries group index increased 0.9 percent.

Rises in the indexes for poly ethylene, alkyd resin, motorcycle tires, rubber pipe, motor cars tires and polyvinyl chloride caused 4.8 percent advance in the group index of plastics and articles thereof, rubber and articles thereof.

The skins and leather and articles thereof group index moved up 5.0 percent, which was principally attributed to the rise of the index for processed sheep skin.

The group index of wood and articles of wood rose 1.2 percent.

As a result of rising in the indexes for clothing, machine-made carpet and gunny, the group index for textiles and textile articles advanced 7.0 percent.

The footwear group index was unchanged.

The 3.1 percent advance in the group index of articles of stone was mainly due to increases in the indexes of building stone, tile, float glass and sanitary porcelain.

The base metals and articles of base metal group index went up 2.5 percent. Rises in the indexes for hot coil iron, galvanized pipe, aluminium ingot, ferromolybdenum and cathode copper were the major reasons for the mentioned increase. In this group, the index for steel profile decreased.

Increases in the indexes for cooler and cable, mainly accounted for the advance in the machinery and mechanical appliances, electrical equipment group index by 7.4 percent.

The vehicles and associated transport equipment group index increased 0.6 percent.

The optical, precision and medical instruments group index had no change.


