Export Price Index in Iran

Dey 1390

(1383 = 100)

The Export Price Index (**XPI**) went up 1.9 percent in Dey 1390^{*} following a 0.6 percent rise in Azar 1390. The index level of 236.9 was 9.8 percent higher than in Dey 1389.

During the first ten months of the current Iranian year, the XPI increased 13.2 percent compared to the similar period in 1389.

The XPI has advanced 12.4 percent over the last twelve months.

In Dey, the animal products group index had no change.

The group index for vegetable products fell 4.7 percent. Decreases in the indexes for saffron, raisin, date, cumin and pistachio were the major factors for the mentioned decline.

As a result of increasing in the indexes for sunflower oil, soya oil and palm oil, the animal or vegetable fats and oils group index moved up 2.5 percent.

The 1.2 percent increase in the group index of prepared foodstuffs, beverages and tobacco was principally attributed to the advances in the indexes for tomato paste, beverage, biscuit and wafer, non-cacao chocolate, cake and ice cream.

The mineral products group index rose 8.6 percent mostly as a result of the advance in the indexes for propane, butane, paraffin wax, cement, bentonit powder and barite powder. Within the mentioned group, the index for tar decreased.

The group index for products of the chemical or allied industries went up 1.4 percent. Increases in the indexes for paraxylene, methanol, shampoo, decorative paints, detergent powder and soap were the major reasons for this advance.

The plastics and articles thereof, rubber and articles thereof group index went down 0.1 percent.

The group index for skins and leather and articles thereof rose 2.5 percent particulary due to the increase in the index for processed sheep skin.

The wood and articles of wood group index advanced 0.6 percent.

Rises in the indexes of hand-woven carpet, baby clothing, rug and tulle mainly accounted for the increase in the textiles and textile articles group index by 2.7 percent. In this group, the index for machin-made carpet declined.

The footwear group index went down 0.5 percent.

During Dey, the articles of stone group index increased 1.3 percent mostly due to the rises in the indexes for building stone and float glass.

The base metals and articles of base metal group index decreased 0.4 percent.

The machinery and mechanical appliances, electrical equipment group index moved up 0.5 percent.

The vehicles and associated transport equipment group index fell 1.4 percent. Reduction in the index for tractor was the main reason for this decrease.

The optical, precision and medical instruments group index was unchanged.


